REPORTS

COUNTY MAYOR

Mayor Anderson asked Emergency Management Agency Director Mac Purdy to address the Commission regarding the County’s efforts to send aid during the recent Hurricanes.

Mr. Purdy stated that 25 individuals were sent to Houston to provide aid and about a dozen additional individuals were sent to Florida. He stated that the individuals are prepared to stay for up to 14 days and stated that this is an example of partnerships in preparedness paying off.

Mayor Anderson thanked Sheriff Long and Dr. Looney for their efforts to collect school supplies for the children in Houston and he thanked the citizen’s of Williamson County for their generous donations.

Commissioner Sturgeon asked about the status of the studies being conducted with regard to the Cool Springs Marriott Conference Center.

Mayor Anderson stated that the County has reached out to a consultant group and stated that he hopes to provide information to the Commission in a couple of months.

Commissioner Ryan asked about the current lawsuit regarding the Educational Impact Fee and asked if there is an anticipated timeline for the case.

County Attorney Jeff Moseley stated that the County has filed an answer to the complaint but stated that he does not have a timeline for the case.

Commissioner Kaestner stated that the Educational Impact Fee will generate approximately \$23,000,000.00 per year for the County. He stated that home builders need to step up and bear some of the costs of the burdens they create.

Mayor Anderson stated that the County will not use any of the money that it has collected from the Educational Impact Fee until the lawsuit is settled.

Mayor Anderson stated that Williamson County has the lowest sales tax in a 9 County area. He stated that he has proposed increasing the sales and use tax in the County from 9.25% to 9.75%.

Mayor Anderson stated that the County currently spends approximately 72% of its total Budget on public education.

Mayor Anderson stated that the County has done a great job in protecting the property tax rate over the years and stated that as the County continues to grow, various additional revenue sources need to be considered. He stated that the majority of growth in the County has taken place in its 6 cities and he stated that he has asked each city to give up its sales and use tax for the next 3 years in order to generate additional revenue for the County. Mayor Anderson stated that the revenue will be used for school construction and he stated that the School Board is in agreement with the proposal. He stated that if every city agrees to the proposal then it will be voted on as a referendum by the citizens.

Mayor Anderson asked Nena Graham, Budget Director, to give the financial report.

Ms. Graham stated that the July Budget Report shows that everything is on track. She stated that the Privilege Tax Reports for July show a continuing positive trend. Ms. Graham stated that the Cool Springs Marriot Conference Center report for June shows positive collections for the County but she stated that the figures for July show negative collections for the County.

Ms. Graham stated that each Commissioner received Form CT-0253, Regarding Qualified Energy Conservation Bonds. (Copies of the letter and attachments are on file in the Clerk's office.)

Ms. Graham stated that each Commissioner received a memo regarding an approval letter from the State of Tennessee Office of State and Local Finance for the issuance of a Tax and Revenue Anticipation Note (TRAN) for fiscal year 2017-18. (Copies of the letter and attachments are on file in the Clerk's office.)

Ms. Graham stated that each Commissioner received a copy of the County's Annual Debt Review Book this evening. (Copy of the Annual Debt Review Book is on file in the Clerk's office.)

## SCHOOLS

Jason Golden, Chief Operations Officer, stated that Dr. Looney is out of town at a Superintendent's meeting.

Mr. Golden stated that the School System has needs all over the County. He stated that although every school will never be equal, the School System strives to bring every school up to certain standards.

Commissioner Herbert asked about the status of acquiring land in the Page area.

Mr. Golden stated that the School System is looking at 3 possibilities. He stated that the School System has the power to condemn but stated that they would prefer to not take those measures. Mr. Golden stated that everything is on track to meet their current timeline for the project.

Commissioner Danner asked if reducing the funding of the Franklin Master Plan to \$2 million until after the Educational Impact Fee lawsuit is settled would stop or derail the project.

Mr. Golden stated that the \$2 million would allow the School System to stay on track until the additional funding is provided.

Commissioner Dwight Jones asked if the final plan for Franklin High includes any part of Cheek Park.

Mr. Golden stated that it currently does not include Cheek Park but that could be looked at in the future.

**RESOLUTION OF THE WILLIAMSON COUNTY BOARD OF COUNTY COMMISSIONERS' APPROVAL OF AN INTENT TO FUND OF \$9,293,500 FOR DESIGN, IMPROVEMENTS AND NEW CONSTRUCTION AT FRANKLIN HIGH SCHOOL FOR THE COLUMBIA STATE CAMPUS AND OTHER BUILDING IMPROVEMENTS ASSOCIATED WITH THE FRANKLIN MASTER PLAN**

**WHEREAS,** the county approved Resolution 3.17.5 granting the Board \$1,500,000 for the immediate renovation of a portion of the Columbia State facility to ensure the needed classroom capacity; and

**WHEREAS,** after all engineering reviews by the appropriate bodies and to meet code requirements for the Columbia State renovation, an additional \$1,793,500 is needed for this portion of the master plan at a total budget of \$3,293,500; and

**WHEREAS,** the renovation of the Columbia State Campus was only a portion of the Franklin Master plan that included other building improvements and construction for Franklin High School; and

**WHEREAS,** there is a need to begin design work and construction for the other remaining projects at an estimated cost of \$7,500,000; and

**WHEREAS,** this resolution’s purpose is to obtain the Commission’s understanding for the need and consent on these projects so that work can begin and as funds are needed, the county will bring further resolutions to fund this project in the manner they see fit through funding sources of their choosing for a total currently estimated **\$9,293,500**;

**NOW THEREFORE BE IT RESOLVED,** that the Williamson County Board of County Commissioners meeting in regular session on September 11, 2017 approve funding of an amount not to exceed **\$9,293,500** for the design, improvements and new construction that needs to take place at Franklin High and take the appropriate actions as necessary to provide funding; and

**BE IT ALSO FURTHER RESOLVED,** that the County may fund the above noted project in anticipation of the issuance of tax exempt bonds, with the expectation that the County will reimburse itself for any funding with the proceeds of the tax-exempt bond issues; and that this resolution shall be placed in the minutes of the Williamson County Board of County Commissioners and made available for inspection by the general public at the office thereof; and that this resolution constitutes a declaration of official intent under Treas. **WHEREAS**, in November 2012, "Vacation Rental Homes" was added as a specific Use Type in the Zoning Ordinance, permitted only in the Leiper's Fork Village Zoning District; and

**WHEREAS**, prior to this change, these uses were not referenced in the Zoning Ordinance and therefore were not regulated; and

**WHEREAS**, since that time, short-term rentals, through companies such as Airbnb and VRBO, have become commonplace in many communities, including the unincorporated areas of Williamson County; and

**WHEREAS**, at this time, there are numerous short-term rental units in the unincorporated County, most of which are located outside the Leiper's Fork Village and most of which have not been approved by the County; and

**WHEREAS**, various bills related to local government regulation of the short-term rental industry have been considered by the Tennessee General Assembly but while this issue is still under consideration by the legislature, none of these bills have been adopted; and



Commissioner Sturgeon stated that she supports the Resolution and stated that she doesn't think it is right to infringe on the rights of property owners if they are not intruding on their neighbors.

In response to questions, Mr. Matteson stated that there are numerous vacation rental homes in the County and he stated that the Codes Department cannot regulate all of them with current staffing.

Joe Horne, Community Development Director, stated that the County needs to be "all in or all out" in terms of regulating vacation rental homes. He stated that the County currently has regulations for temporary and permanent venues. Mr. Horne stated that there has not been a great deal of problems with vacation rental homes and stated that enforcing regulations on them will be very hard.

Commissioner Williams called for the question. Seconded by Commissioner Dwight Jones.

The motion passed by voice vote.
