Abstract: The Ordinary, Tavern, and Tippling Licenses collection contains records pertaining to the regulation of the sale of alcohol, food, and lodging as controlled and maintained by the Williamson County Court in the 1800s.

Scope and Content

This collection contains Williamson County court bonds and licenses issued from 1800-1888. These bonds and licenses were issued in order to regulate and maintain the sale and consumption of alcohol, food, and lodging offered commercially in Williamson County, TN.

Arrangement

The records are arranged chronologically by the filed date.

Historical Note

The 19th century was a significant time in Tennessee history. After gaining statehood in 1796, settlers continued to spread out and populate the state throughout the 1800s. In small villages and towns, ordinaries were an integral part of the community. Ordinaries served as a hub for community meetings, news, drinking, and socializing. Today, the terms “Tavern”, “Ordinary”, and “Inn” are often used interchangeably, and describe the same general establishment.

Historically, an ordinary was an establishment where members of a community and travelers could find amenities such as lodging, a bed, food, and drink. The services provided by inns, ordinaries, and taverns were regulated by law. Even the price of a complete meal served at a tavern could be controlled. The right to serve alcohol was also regulated. “Tippling” bonds and licenses were issued to establishments allowed to serve alcohol. “Tippling” means to drink alcohol excessively or habitually. In colonial America, liquor serving establishments were sometimes referred to as “Tippling houses”.

As the 1800s progressed, so did the Temperance Movement, which was a social movement to limit or eradicate the consumption of alcohol. The “Poison Bond and Affidavit” contained in the later part of this record group is a reflection of the Temperance Movement’s impact. As taxes on alcohol increased, people that made and sold alcohol began to try to create more product for less money. Many times, this meant diluting alcohol with water and then having to recreate the color, flavor, and even the effects of the alcohol with other substances. Therefore, sugar, molasses, sawdust, other nonconventional items, and even some poisons were used to recreate the expected drink- hence the Liquor Inspection and the Poison Bond and Affidavit you will see in this record group. On March 15, 1860, The Tennessee General Assembly passed an act entitled “An act to prevent the adulteration of spirituous and vinous liquors in this State.”
