Scope and Content

This collection contains mostly correspondence to E. Ward Harris. This correspondence includes personal, professional, and advertisements. This collection also contains court-related materials, legal documents, personal identification documents, a photograph, government documents, periodicals, insurance, and retirement documents.

All items in the collection are contained within two record boxes. Items are separated by category within acid-free folders. The folders are arranged alphabetically within each box. The boxes are stored in the processing room on the rear wall shelf.

Historical Note

E. Ward Harris was born on February 17, 1909, in Maury County, Tennessee. He was the son of Sophia Jane Holland Harris and McDonald Harris. He was a lawyer in Franklin, Tennessee and held residence in Spring Hill, Tennessee. Most of the correspondence between E. Ward Harris, his clients, corporations, and other law offices indicates that he mainly practiced law in the areas of life insurance and debt collections. He died in Panama City, Florida on December 8, 1989.
