## **MINUTES OF THE HIGHWAY COMMISSION MEETING**

**May 7, 2025**

The Williamson County Highway Commission met on Wednesday, May 7, 2025, at 8:30 a.m. at the Williamson County Highway Department facility at 302 Beasley Drive in Franklin, TN. Commission members present were County Mayor and Highway Commission Chairman, Rogers Anderson; Highway Commissioners David Coleman, Wayne Davis, Stan Tyson, and Charles Wilson.

Also present were Eddie Hood, Highway Superintendent; Greg Boll and Amie Bennett, Highway Department; Michael Matteson, Community Development Director; Aaron Holmes, Planning Director; Floyd Heflin and Michael Scott, Engineering; Leslie Mitchell, Purchasing Director; Bobby Cook, County Attorney and other interested individuals.

Chairman Anderson called the meeting to order at approximately 8:30 am and called for the approval of the minutes from the April 2, 2025 meeting. Commissioner Tyson moved for approval, seconded by Commissioner Davis. The motion for approval of the minutes passed by unanimous voice vote, 5-0.

**SPECIAL ANNOUNCEMENTS:** There were no special announcements.

**CITIZEN COMMUNICATIONS:** Chairman Anderson explained the rules for Citizens Communication. Ms. Dana Frick of Franklin expressed her concern about the safety of the intersection at West Harpeth at Columbia Pike with the traffic.

### **ELECTIONS AND APPOINTMENTS:**

#### **OLD BUSINESS:**

1. SEC Engineering requesting road improvements on Patterson Road was pulled by Superintendent Hood.

#### **NEW BUSINESS:**

1. Greg Gamble with Gamble Design Collaborative, requesting driveway cuts on Coleman Road. Mr. Gamble stated to the board members that the request is to connect to Coleman Road for eight residential lots. Superintendent Hood expressed his concerns with the City of Franklin. Mr. Bobby Cook announced there are issues needing to be addressed before moving forward. Commissioner Tyson recommends leaving as is until more information is available. Commissioners Coleman, Davis and Wilson would like more information. No action was taken.
2. Crunk Engineering, requesting off site road improvements on Malachi Lane. Will Crunk explained the modification will include a turning lane on Malachi Lane with a traffic signal to help with traffic on to Horton Highway. Superintendent Hood included that Crunk Engineering will pave Malachi Lane and recommends approval. Mr. Chad Collier noted that he recommends approval. Commissioner Wilson moved for approval, seconded by Commissioner Tyson. The motion passed 5-0.
3. Paige Thomas for approval of curb in Timberline Subdivision at Sneed Road. Ms. Sierra, resident of Timberline Subdivision, explained that the curb would be at the entrance of the subdivision and the HOA would be responsible for the funding. Superintendent Hood recommends approval. Commissioner Tyson moved for approval and seconded by Commissioner Coleman. The motion passed 5-0.
4. Kate McDonald with CSDG, requesting sewer line on Spencer Creek Road. Ms. McDonald explained that if her request is approved, she is asking that Spencer Creek Road close allowing local traffic. Ms. McDonald included that she would notify the schools and first responders of the road closure. Superintendent Hood is requesting the work begin when school is out for summer and informed Ms. McDonald that a letter of credit is required as well as a permit, Mr. Hood recommends approval. Commissioner Wilson moved for approval seconded by Commissioner Tyson, the motion passed 5-0.
5. Report for acceptance of Second Creek Lane, Water Leaf Subdivision, section two (2) as part of the Williamson County Road System. Superintendent Hood recommends approval and states that a resolution will follow. Mr. Michael Scott recommends approval. Commissioner Coleman moved for approval, seconded by Commissioner Davis. The motion passed 5-0.
6. Resolution requesting prioritization for the widening of Interstate 65 from Interstate 840 [exit 59] to Bear Creek Pike [exit 46]. County Commissioner Graves explained that this resolution will be put on TDOT's radar to relieve traffic. Superintendent Hood agrees and supports the resolution. Commissioner Wilson moved for approval, seconded by Commissioner Tyson. The motion passed 5-0.

### **HIGHWAY COMMISSION DISTRICT REPORTS:**

- NW District Commissioner Tyson commended the Highway Department for the work done during the flood and response time with potholes.
- SW District Commissioner Davis reported one issue but was taken care of.
- NE District Commissioner Coleman had nothing to report.
- SE District Commissioner Wilson had nothing to report.

**HIGHWAY SUPERINTENDENT REPORT:** Superintendent Hood reported that the Highway Department is busy with paving and bush hogging. Chad Collier, with Collier Engineering, reported that the replacement bridge on Sneed Road is delayed due to a 36" waterline, and will now have to do one half at a time. Mr. Collier included that traffic signals and detour signs will be placed accordingly.

**HIGHWAY CHAIRMAN REPORT:** Mayor and Chairman Anderson had nothing further to report.

**LEGAL ISSUES:** Mr. Cook had nothing to report.

**ADJOURNMENT:** There being no further discussion, the meeting adjourned at 9:08 a.m.
