THE QUALIFYING DEADLINE FOR REPUBLICAN DELEGATES to the Republican National Convention is Thursday, December 14, 2023, at 12:00 noon prevailing time. In order to qualify as a candidate for any of the offices in the PRESIDENTIAL PREFERENCE PRIMARY, qualifying petitions and other supporting documents must be filed in the office of the Coordinator of Elections at the Tennessee Division of Elections, 312 Rosa L. Parks Avenue, 7th Floor, William R. Snodgrass Tower, Nashville, Tennessee, 37243. (615) 741-7956. **THE QUALIFYING DEADLINE FOR CANDIDATES SEEKING NOMINATION BY ELECTION IN THE COUNTY REPUBLICAN OR COUNTY DEMOCRATIC PRIMARY** for Circuit Court Judge, Division III- 21st Judicial District (unexpired term), District Attorney General-21st Judicial District (unexpired term), County Commission-District 6 (unexpired term) Assessor of Property, County Board of Education (Odd Numbered Seats), Franklin Special School District (Three Seats) is Thursday, December 14, 2023, at 12:00 noon, prevailing time. **INDEPENDENT CANDIDATES** seeking election to the offices of Circuit Court Judge, Division III- 21st Judicial District (unexpired term), District Attorney General-21st Judicial District (unexpired term), County Commission-District 6 (Unexpired Term), Assessor of Property, County Board of Education (Odd Numbered Seats), Franklin Special School District (Three Seats) must also file their nominating petition in the Election Commission office no later than 12:00 Noon prevailing time on December 14, 2023, in order for their names to appear on the official ballot for the August 1, 2024, County General Election. *Qualifying petitions for the above named local offices are issued at the Election Commission Office. (T.C.A. §§2-13-203(e) and 2-5-101 (a) (2))*

WITHDRAWAL DEADLINE

On or before December 21, 2023, 12:00 P.M. Noon, prevailing time, candidates may withdraw their names from the official ballot: request is to be in writing, signed by the candidate, and submitted to the Election Commission office or at the Tennessee Division of Elections (if applicable). (T.C.A. § 2-5-204 (b) (1))

VOTER REGISTRATION DEADLINE

The deadline to register to vote is **Monday, February 5, 2024, 4:30 P.M.** Voter registration forms can be obtained at the Tennessee Department of Safety Driver Testing Centers, the Department of Human Services, Williamson County Health Department, any library within Williamson County or you may register online on our website at www.williamsonvotes.net. Voter registration forms postmarked no later than February 5, 2024, will be processed for this election. Persons already registered in Williamson County may have their permanent voter registration records altered upon receipt of a written notification, over the voters' signature, on or before February 29, 2024. **Persons registering to vote by mail must appear in person the first time he or she votes either on Election Day or during the early voting period. Before voting**

at the appropriate polling place, election commission office or early voting site such person shall present satisfactory proof of identity. (T.C.A. § 2-2-109 and 2-2-115 (b) (7))

Thursday and Friday, November 23 & 24, 2023, for the Thanksgiving holiday.**
