Only registered voters residing within the corporate ward limits of the City of Franklin are entitled to vote in person for this election. **ANY CITY OF FRANKLIN VOTER MAY VOTE AT ANY LOCATION LISTED BELOW REGARDLESS OF THEIR RESIDENTIAL ADDRESS INSIDE THE CORPORATE LIMITS OF THE CITY.**
